LABOUR STATISTICS CONVENTION, 1985 (No. 160)

General Comment

Relevant changes to New Zealand policy and practice which have occurred since the last report on the Labour Statistics Convention No.160 are outlined below. For all other details regarding New Zealand's application of this convention, please refer the Government's report for the period November 2001 to 31 May 2003.

I. GENERAL PROVISIONS

Article 2

In designing or revising the concepts, definitions and methodology used in the collection, compilation and publication of the statistics required under this Convention, Members shall take into consideration the latest standards and guide-lines established under the auspices of the International Labour Organisation.

Please indicate, for each of the Articles of Part II in respect of which your Government has accepted the obligations, whether the latest standards and guide-lines established under the auspices of the International Labour Organisation have been followed and the reasons for any departures therefrom.

The latest standards and guidelines are considered, and for the most part implemented, for all of the articles of Part II. Areas where New Zealand does not meet the latest standards and guidelines were outlined in our previous reports for the periods November 2001 to 31 May 2003 and 1 June 2003 to 31 May 2005.

(b) the most recent dates or periods for which the different types of statistics are available, and the dates of their publication or release.

Work-related injury claims accepted and administered by the Accident Compensation Corporation under the *Injury Prevention, Rehabilitation and Compensation Act 2001*.

II. BASIC LABOUR STATISTICS

Article 13

Statistics of household expenditure or, where appropriate, family expenditure and, where possible, household income or, where appropriate, family income shall be compiled covering all types and sizes of private households or families, and in such a way as to be representative of the country as a whole.

These statistics are covered by the **Household Economic Survey** and the **Household Economic Survey (Income)**. The Household Economic Survey (Income) is a shortened version of the full triennial Household Economic Survey (HES). HES (Income) runs in the two intervening years between the full HES to collect data on household and personal income, living standards, and housing cost expenditure.

The survey target population and household membership rules of the Household Economic Survey (Income) are the same as that of the Household Economic Survey, which were detailed in the Government's report for the period November 2001 to 31 May 2003.

Response to the Direct Request of the Committee of Experts on the Application of Conventions and Recommendations (CEACR) on Convention 160

Article 12 of the Convention: Consumer price indices

Noting the Government's indication in relation to Article 12 that the latest standards and guidelines have been followed, the Committee would be grateful if it would indicate which standards and guidelines are referred to (Article 2).

Please see the updated reference to article 12 under Article 2 in the report above.

Article 14: Statistics of occupational injuries and occupational diseases

Noting that the provisions of the Convention on statistics of occupational injuries are in general applied and that the compilation of injury statistics is currently at the development stage with a view to integrating the various administrative sources of data and completing the coverage of these statistics, the Committee asks the Government to keep the ILO informed of any progress in this regard and to provide any available information on the compilation of statistics of occupational injuries.

The Committee would be grateful if the Government would ensure that statistical publications containing data on occupational injuries are communicated to the ILO, and particularly the publication "Injury Statistics: Work-related Injuries" (Article 5).

The production and publication of statistics on work-related claims for injuries now occurs annually and statistics for 2002 to 2008 are available. This collection is released as a Hot Off the Press, which includes a summary of the results and an excel table set published on Statistics New Zealand's website. Table Builder tables, which enable users to generate data tables to their own specifications, were also developed for this collection and provided on the Statistics New Zealand website. The latest release is listed in article 14 under Article 2 in the report above.

In 2011 Statistics New Zealand will publish and further develop the "Serious Injury Outcome Indicators" that include indicators of work-related injuries. These indicators have been produced annually for the New Zealand Injury Prevention Strategy Secretariat and the latest reports are listed below:
