Through the reference 1<sup>st</sup> cited, the Government has introduced the Third Party Audit Scheme for Medium Risk Industries / Establishments in accordance with the norms of Ease of Doing Business and through the reference 2<sup>nd</sup> cited, revised the Third Party Audit Scheme for Medium Risk Industries / Establishments by superseding the G.O. 1<sup>st</sup> read above, to further facilitate Ease of Doing Business in the State to increase the enrolment under Third Party Audit Scheme.

Through the reference 3<sup>rd</sup> cited, Sri P S G Prasad, Artha HR Services has applied for the enrolment as Third Party Auditor firm under Third Party Audit Scheme. The Commissioner of Labour, Telangana, Hyderabad, after examination of the application of empanelment of Auditor firm and obtaining the report from standing committee, is hereby decided to select the "Artha HR Services" as Third Party Auditor firm under Third Party Audit Scheme for Medium Risk Industries / Establishments in accordance with the norms of Ease of Doing Business for the period of two years.

It is hereby inform that the said Third Party Auditor firm should follow and act according to the duties and responsibilities of the Third Party Auditor Firms and other terms and conditions prescribed in the G.O. 2<sup>nd</sup> cited.

The empanelled third party auditor shall submit the refundable Security Deposit for 2 years in to Department of Labour from a scheduled / nationalized bank through DD drawn in favour of the Commissioner of Labour, Telangana, Hyderabad or by Online Transfer for an amount of Rs.50,000 (Rupees Fifty Thousand only).

The Project Manager, CGG is requested to take necessary action for display of the said firm i.e., Artha HR Services under empanelment list of third party auditor firm on the website of Labour Department.
