**ORDER:**

The Director of Factories, A.P., Hyderabad in his letter read above has stated that occupier of M/s Aurobindo Pharam Limited, VI, located at Survey No.329/39 & 329/40 in Chitkul (V) Patancheru (M) Medak District has informed that it is proposed to bifurcate the said factory into two separate factories based on the manufacturing activity for administrative and process management convenience. They propose to have one unit exclusively for manufacturing of bulk drugs in the name of Aurobindo Pharma Limited Unit XV and the second unit for manufacturing of sterile Pharmaceutical formulation in the name of Aurobindo Pharma Limited Unit No.VI.

2. The Director of Factories has further stated that under proviso section 4 of the Factories Act 1948 (Act No.XIII of 1948) the State Govt., may (on its own) or an application made in this behalf by a occupier, direct by an order in writing (and subject such conditions as it may deem fit) that for all or any of the purpose of the Act, different Departments or branches of a Factory of the occupier specified in the application shall be treated as Separate Factories or that two or more of the occupier specified in the application shall be treated as a singly Factory. The annual License fees due to the bifurcation would increase by Rs.22,000/-. However the workers employed in the propose second unit i.e., “Aurobindo Pharma Limited Unit VI” would be 152 only in which case some or the welfare amenities being provided to them in the present Factory will not be available in the said workers.

3. Government after careful examination of the matter hereby permit the Director of Factories, A.P., Hyderabad to take necessary action for separation of the factory of M/s Aurobindo Pharma Limited Factories License No.30689 into two Units namely “Aurobindo Pharma Limited Unit –XV” (Bulk Drugs) and “Aurobindo Pharma Limited, Unit No.VI (Sterile Pharmaceutical formulations) subject to the condition that the welfare amenities like canteen, rest shed, Occupation Health Center etc., being provided presently to all workers shall be extended to the workers employed in the second unit also namely “Aurobindo Pharma Limited – XV” after the bifurcation and also for taking rules in force.

4. The Director of Factories, A.P., Hyderabad is requested to take further action in the matter.
