ORDER

In the reference 1<sup>st</sup> read above, the Director of Factories has submitted proposals for filling up of two vacancies of Joint Chief Inspector of Factories in the office of the Director of Factories, Andhra Pradesh, Hyderabad and to convene the Departmental promotion Committee meeting to consider and recommend the names for the panel year 2009-2010. The Director of Factories furnished a seniority list of 6 Deputy Chief Inspector of Factories. Out of 6 (Six), 5 (Five) Deputy Chief Inspector of Factories are qualified for placing before the Departmental promotion Committee.

Accordingly, the Departmental promotion Committee met on 12-10-2009, and after going through the A.C.Rs., relevant records and other material papers of the Deputy Chief Inspector of Factories, in the seniority list and after making an overall assessment of their service record and work, recommended that the names of the following Deputy Chief Inspector of Factories be included in the panel, for promotion as Joint Chief Inspector of Factories, for the panel year 2009-2010:-

1. Sri Ch.Kishan
2. Sri P.M. Chandramohan

3. The Committee considered that reservation in promotions for SC/ST is not applicable, as the cadre strength of Joint Chief Inspector of Factories, is 4 only.

4. Government, after careful examination of the recommendation of the Departmental promotion Committee, hereby approve the names of 1) Sri Ch.Kishan, 2. Sri P.M. Chandramohan, Deputy Chief Inspectors of Factories, fit for promotion to the category of Joint Chief Inspector of Factories in Factories Department and accordingly include their names in the panel of Deputy Chief Inspector of Factories for appointment to the post of Joint Chief Inspector of Factories for the panel year of 2009-2010.

5. The Director of Factories shall take further action accordingly and furnish necessary proposals for issuance of posting orders along with the vacancy position and place of posting available in the Department immediately.
