The following notification will be published in the Extra Ordinary issue of the Andhra Pradesh Gazette Dated on 11th November, 2009.

NOTIFICATION

In exercise of the powers conferred by section 27 of the Minimum Wages Act,1948 (Central Act 11 of 1948), the Governor of Andhra Pradesh hereby amend the existing entry 60 of the Part-I of schedule to the minimum Wages Act,1948 and the notice of intention to do so having been previously issued in G.O.Ms.No.44, Labour Employment Training and Factories (Lab.II) Department, dated the 5th May, 2007 and published in the Rule Supplement to Part-I Extraordinary Issue of Andhra Pradesh Gazette No. 594-A dated the 20th day of October, 2008 as required under Section 27 of the said Act .

AMENDMENT

In Part-I of the schedule to the Minimum Wages Act, 1948, for the existing entry 60, the following entry shall be substituted, namely:-

“60 Employment of Non- teaching Staff working in Private Educational Institutions including Tutorial Institutions and Computer Coaching Centres.”
