The following notification shall be published in the next Extraordinary issue of the Andhra Pradesh Gazette:

NOTIFICATION

In exercise of the powers conferred under section 70 of the Andhra Pradesh Shops and Establishments Act, 1988, (A.P Act No.20 of 1988) and in supersession of all previous notifications issued in this behalf, the Government of Andhra Pradesh hereby directs that the powers exercisable by the Government under sub-section (1) of section 31 and sub-section (4) of section 73 in respect of granting exemption from section 68 and granting temporary exemption from sub-section (1) of section 7, sub-section(1) of section 12 and sub-section (1) of section 31 for a period up to one month in a Calendar year and section 76 of the said Act shall also be exercisable by the Joint Commissioners of Labour in their respective jurisdiction as shown in the Annexure appended to this order.
