**ORDER:**

In partial modification of the G.O. 2<sup>nd</sup> read above, the following revised instructions in regard to appointment of officers for registration, licensing and renewal under the following Labour Enactments are hereby issued:-

- 1. SHOPS AND ESTABLISHMENTS ACT, 1988:-** In exercise of the powers conferred under section 71 of the above Act, the registering officers are, as specified in Annexure appended to this order for registration of shop or establishments under section 3 of the said Act and renewal of registration as per section 4 of the said Act.
- 2. Beedi and Cigar Workers (Conditions of Employment) Act, 1966:-** In exercise of the powers conferred under section 44 of the above Act, the licensing officers are, as specified in the Annexure appended to this order for registration of beedi and cigar establishment under section 4 (1) of the said Act and renewal of registration as per section 4 (4) (a) (b) of the said Act .
- 3. Motor Transport workers Act, 1961:-** In exercise of the powers conferred under section 40 of the above Act, the registering officers are, as specified in the Annexure appended to this order for registration of motor transport undertaking under section 3 of the said Act and renewal of registration as per rule 8 of Motor Transport Workers Rules,1963.
- 4. Contract Labour (R&A) ACT, 1970:-** In exercise of the powers conferred under section 35 of the above Act, the registering officers are, as specified in the Annexure appended to this order for registration of Principal employer under section 6 (a) of the said Act and Licensing of contractors under section 11 (a) of the said Act .
- 5. Inter State Migrant Workmen (Regulation of employment and conditions of service) Act, 1979:-** In exercise of the powers conferred under section 35 of the above Act, the registering officers are, as specified in the Annexure appended this order for registration of Principal employer under section 3(a) of the said Act and Licensing of contractors under section 7(a) of the said Act.
- 6. Building and other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996:-** In exercise of the powers conferred under section 62 of the above Act, the registering officers are, as specified in the Annexure appended to this order for registration of establishments under section 6 (a) of the said Act.
