ORDER:-

Whereas, by section 101 of the Andhra Pradesh Reorganization Act, 2014 (Central Act No. 6 of 2014), the appropriate Government i.e. the State of Telangana is empowered, by order, to make such adaptations, and modifications of any law made before 02.06.2014, whether by way of repeal or amendment as may be necessary or expedient, for the purpose of facilitating the application of such law in relation to the State of Telangana, before expiration of two years from 02.06.2014 and thereupon every such law shall have effect subject to the adaptations and modifications, so made until altered, repealed or amended by a competent Legislature or other competent authority;

2. And whereas, it has become necessary to adapt, with modifications and amendments the Andhra Pradesh Shops and Establishments Rules, 1990, in force as on 1.6.2014 for the purpose of facilitating its application in relation to the State of Telangana;

3. And whereas, after careful examination, Government have decided to adapt the Andhra Pradesh Shops and Establishments Rules, 1990 as amended from time to time with necessary modification, so as to facilitate its application to the State of Telangana.

4. Accordingly, the following notification will be published in an Extraordinary Issue of the Telangana Gazette, dated: 05.02.2016.

NOTIFICATION

In exercise of the powers conferred by section 101 of the Andhra Pradesh Reorganization Act, 2014 (Central Act No.6 of 2014), the Government of Telangana hereby adapt the Andhra Pradesh Shops and Establishment Rules, 1990 as, amended from time to time which are in force as on 01.06.2014 to the State of Telangana with the following modifications, so as to facilitate its application to the State of Telangana:-

1. (1) This order may be called the Andhra Pradesh Shops and Establishments Rules, 1990 – (Telangana Adaptation) Order, 2016.

(2) It shall be deemed to have come into force w.e.f. 02.06.2014.

2. For the purpose of this Order, and the Rules adapted herein the expression "the State" shall have the meaning and area as specified in section 3 of the Andhra Pradesh Reorganization Act, 2014.

3. In the said Rules as amended from time to time, for the words “Andhra Pradesh”, occurring throughout the Rules otherwise than in a title or citation or description etc., the word “Telangana” shall be substituted.

4. In rules 7 and 18, for the words “Labour Officer”, wherever they occur, the words “Assistant Commissioner of Labour” shall be substituted.

5. In rule 29, after sub-rule (13), the following proviso shall be added; namely:

“Provided that the Government may by order, devise or notify consolidated forms for maintaining registers and records and furnishing reports in lieu of the prescribed formats under the rule.”

6. In rule 33, the following provisos shall be added; namely:

“Provided that the Government may by order, devise or notify consolidated form for furnishing periodical Returns in lieu of the prescribed formats under the rule:

Provided, further that the Government may allow the registers, records and returns to be maintained in computerized or digital format or physical format, as the case may be”.
