Sub: LET&F Department – BRAP, 2019 – Facilitation of Registration and Renewal under the Telangana Shops & Establishments Act, 1988 as part of Ease of Doing Business in Telangana State – Instructions – Issued.

Ref:1. Act.No.28/2017 to amend the Telangana Shops and Establishments Act, 1988.

2. BRAP, 2019 guidelines received from the DIPP, GOI, New Delhi.

3. From the Commissioner of Labour, Telangana, Hyderabad, Lr.No.H2/6610/2018, dated: 13.11.2018.

The attention of the Commissioner of Labour, Telangana, Hyderabad is invited to the reference 1<sup>st</sup> cited wherein the Telangana Shops and Establishments Act, 1988 was amended and the certain provisions were added to the Section (3) sub-section (2) of the Act, namely, no inspection need be conducted prior to registration and on uploading the application for registration along with other enclosures as may be prescribed, provisional registration shall be granted within 24 business hours and be valid until a final order is passed on the application for registration.

2. In the reference 3<sup>rd</sup> cited, the Commissioner of Labour, Telangana, Hyderabad has proposed to implement the BRAP, 2019 recommendations with following provisions:

- (i) Ensure that the final registration is granted within one day from the date of application
- (ii) Eliminate the requirement of renewal of registration.

3. In this regard, it is clarified that vide reference 1<sup>st</sup> cited, the requirement of inspection prior to registration is dispensed with. Further, the amendment Act provides that within 24 business hours, provisional registration certificate has to be issued. As the inspection prior to registration is dispensed with, the Commissioner of Labour, Telangana, Hyderabad is instructed that in order to further facilitate Registration under the Telangana Shops and Establishments Act, 1988, final order and issue of certificate of registration shall also be completed within 24 business hours from the time of online uploading of application for registration with other enclosures as may be prescribed. Further, in order to eliminate the requirement of renewal of registration, the registration certificate under the Telangana Shops and Establishments Act, 1988, once issued, may be treated as permanent. However, the employer shall continue to pay the fee prescribed for extending the validity of registration by 1<sup>st</sup> December of every year.
